

Appendix A

RULES FARMERS' MARKET

The farmer's market was created by TLU SA to give farmers the opportunity to sell their products directly to the consumer. TLU SA is the owner of all shares in the company that owns and operates the market. TLU SA's objective is to keep farmers safe and sustainable on their farms and all income is used to achieve the objective.

The Pretoria Boeremark (Pty) Ltd reserves the right to amend any rule without giving reasons with 2 weeks written notice.

The right of access is reserved at all times.

GENERAL

1. Only agricultural products and related products, such as food, handmade articles, and related products, at the discretion of the farmer's market may be offered for sale.
2. A ban can be placed at any time on the sale of any article.
3. Any dispute will be resolved by the market's management.
4. Complaints from customers will be resolved by the stall holder without interference from the management.
5. Generators will only be allowed in case of power outages. If its noise is excessive, the management may prohibit its use.
6. The stall holder must comply with all legal prescriptions, regulations and health conditions.
7. Advertising and marketing materials may not be placed in the streets or obstruct any movement of people.

AWARD OF STALL

8. If your application has been approved, come and choose a vacant card stall in the office and make a note of the number(s).
9. Check the site and when you have decided which has the best location, visit the office again and contract for the use of the stall.
10. Make the required initial payments no later than the Wednesday before the relevant Saturday

FEES

11. R500.00 entry fee is payable which is not refundable under any circumstances.
12. R1 150.00 per month payable in advance. The fee is payable whether or not the stall is occupied every Saturday.
13. All fees are payable in advance. Payments can be made by EFT or by card in the office - Pretoria Boeremark - FNB - 62383915629 - 250655

14. Failure to pay any fee on time will result in the contract being canceled immediately, without any notice.

VEHICLES

15. No vehicles are allowed to move on the site between 5.30 and 9.30.

16. All vehicles must be parked in the designated areas.

17. No vehicle may drive faster than 15 km/h on the site, it is one-way traffic - enter at Morelettastreet and exit at Krigestreet.

STALL

18. Own chairs tables etc. must be provided. Exhibitors may not use the chairs or tables from the farmers market for their stalls

19. Stalls must be left clean and tidy behind.

20. No Farmers' Market staff may be employed for the general maintenance of the stalls during weekday working hours or during Saturday working hours. No work is allowed on Sundays.

21. Where electricity is available, a fee of R 150.00 per month will be payable in advance for use for lights/ mobile phone charger or card machine charger. For any other device, a rate is calculated and agreed in writing for payment per month.

ERECTION OF STRUCTURES

22. Take note that a large part of the farmer's market site is below the 100 year flood line and that water may run through the site.

23. Permission must be obtained from the Management for the erection of a structure.

24. The places where poles are planted will be shown by management

25. Structures should preferably be made of wood and a roof that is green. Any other material must be pre-approved.

26. No electricity may be installed without the management's approval.

27. Plugging in power from neighbors is prohibited

28. If you are no longer able/willing to rent the stall space, and there is still an outstanding debt towards Pretoria Boeremark, the Boeremark reserves the right to sell the structure to recover the debt.

29. Until such time as the structure is either sold or removed, the rent thereof shall continue to be paid.
